General Terms & Conditions:

- This Tariff Applies for the Public Performance of Cinematograph Film Work at the premises for general public by any display by way of television, LCD or any Digital wireless or with wire diffusion as given under the definition of "Communication to the Public" pursuant to Section 2(ff) of Copyright Act 1957 read with Copyright Rule 2013 with amendment thereof.
- The above tariff " is not valid for any Commercial Event " in respect to Cinematograph Film Work (e.g. Shows, promotions, product launches, fashion shows, DJ parties, New Year Events etc.). For all events / shows organised in the said category for Cinematograph Film Work, a separate Event License has to be obtained from CINEFIL. For Events Licence of CPL , not limited to temporary embodiment / storage a separate Licence shall be charged which our authorised representatives will explain the proposed tariffs.
- Tariffs shown are on per annum basis for CPL (Cinematographic Performance License) plus GST as applicable
- The rates are only valid if CPL (Cinematographic Performance License) is obtained prior to content being used. If payment is received post infringement, the regular tariff shall not apply. Interest and liquidated damages shall apply as per company policy.

Section 2(ff) of Copyright Act 1957 - "Communication to the Public" means making any work available for being seen or heard or otherwise enjoyed by the public directly or by any means of display or diffusion other than by issuing copies of such work regardless of whether any member of the public actually sees hears or otherwise enjoys the work so made available.

Explanation : For the purposes of this clause communication through satellite or cable or any other means of simultaneous communication to more than one household or place of residence including residential rooms of any hotel or hostel shall be deemed to be communication to the public;
